EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0314

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of July 25 through July 31, 2021 because her claim for that week was late (decision # 123224). On September 7, 2021 decision # 123224 became final without claimant having filed a request for hearing. On June 20, 2023, claimant filed a late request for hearing. ALJ Kangas reviewed the request, and on December 6, 2023 issued Order No. 23-UI-242709, dismissing the request as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by December 20, 2023. On December 18, 2023, claimant filed a timely response to the appellant questionnaire. ALJ Scott considered the response, and on February 26, 2024 issued Order No. 24-UI-248890, re-dismissing claimant's request for hearing as late without a showing of good cause. On March 18, 2024, Order No. 24-UI-248890 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 26, 2024, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 24-UI-248890, mailed to claimant on February 26, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-248890 at 3. Order No. 24-UI-248890 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 18, 2024 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-248890 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-248890 was due March 18, 2024. Because claimant did not file their application for review until March 26, 2024, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented her from filing the application for review by the March 18, 2024 deadline. Accordingly, claimant did not show good cause for the late application for review, and the late application for review is dismissed.

DECISION: Order No. 24-UI-248890 is affirmed.
