

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0318**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On February 7, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning January 7, 2024, because claimant quit working for the employer without good cause (decision # 135721). Claimant filed a timely request for hearing. On March 13, 2024, ALJ Janzen conducted a hearing, and on March 14, 2024, issued Order No. 24-UI-250080, modifying decision # 135721 by concluding that claimant was disqualified from receiving benefits effective January 14, 2024. On March 28, 2024, claimant filed an application for review of Order No. 24-UI-250080 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-250080's findings of fact, reasoning, and conclusion that claimant quit work without good cause and was disqualified from receiving benefits effective January 14, 2024. Pursuant to ORS 657.275(2), Order No. 24-UI-250080 is **adopted**.

**DECISION:** Order No. 24-UI-250080 is affirmed.
