

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0323**

*Application for Review Dismissed*  
*No Justiciable Controversy*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On February 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits for the weeks from December 10, 2023, through February 3, 2024, and until claimant provided retirement income information the Department had requested (decision # 71431). Claimant filed a timely request for hearing. On March 12, 2024, ALJ Roberts conducted a hearing and issued Order No. 24-UI-249883, reversing decision # 71431 by concluding that claimant had provided the information the Department had requested and was eligible for benefits for the weeks from December 10, 2023, through March 2, 2024, if otherwise eligible. On March 27, 2024, claimant filed an application for review of Order No. 24-UI-249883 with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** With their application for review, claimant submitted additional evidence for EAB's consideration. EAB did not consider the additional evidence because it is not relevant and material to EAB's determination of whether claimant's application for review of Order No. 24-UI-249883 should be dismissed. ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019).

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 24-UI-249883 presents no justiciable controversy and is dismissed.

On March 27, 2024, claimant filed with the Employment Appeals Board (EAB) an application for review of an order that allowed the appellant (claimant) benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 24-UI-249883 is dismissed and Order No. 24-UI-249883 remains undisturbed.

**DECISION:** The application for review filed March 27, 2024, is dismissed. Order No. 24-UI-249883 remains undisturbed.
