EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0334

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 28, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of December 10 through December 16, 2023, and until claimant registered work following the rules set by the Department. On January 17, 2024, the December 28, 2023, administrative decision became final without claimant having filed a request for hearing. On February 20, 2024, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's request, and on March 4, 2024, issued Order No. 24-UI-249332, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 18, 2024. On March 25, 2024, Order No. 24-UI-249332 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On April 3, 2024, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 24-UI-249332 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire attached to Order 24-UI-249332, and has been marked as EAB Exhibit 1 and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 24-UI-249332, mailed to claimant on March 4, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-249332 at 2. Order No. 24-UI-249332 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than March 25, 2024."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-249332 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-249332 was due March 25, 2024. Because claimant did not file their application for review until April 3, 2024, the application for review was late. With their application for review, claimant included a response to the appellant questionnaire attached to Order No. 24-UI-249332. EAB Exhibit 1. However, claimant's response did not describe circumstances preventing claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed April 3, 2024, is dismissed. Order No. 24-UI-249332 remains undisturbed.
