EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0339

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 24, 2024, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report concluding that claimant did not qualify for unemployment insurance benefits. On February 4, 2024, the Wage and Potential Benefit Report became final without claimant having filed a request for hearing. On February 20, 2024, claimant filed a late request for hearing. ALJ Scott reviewed claimant's request, and on February 28, 2024, issued Order No. 24-UI-249094, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 13, 2024. On March 19, 2024, Order No. 24-UI-249094 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On April 12, 2024, claimant filed a late response to the appellant questionnaire and a late application for review with EAB. On April 15, 2024, ALJ Kangas mailed claimant a letter stating that because claimant's response to the appellant questionnaire was late, it would not be considered, and another order would not be issued regarding the matter. This matter comes before EAB based on claimant's April 12, 2024, late application for review of Order No. 24-UI-249094.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence claimant's response to the appellant questionnaire attached to Order No. 24-UI-249094, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. 24-UI-249094, mailed to claimant on February 28, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-249094 at 2. Order No. 24-UI-249094 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than March 19, 2024."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-249094 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-249094 was due March 19, 2024. Because claimant did not file their application for review until April 12, 2024, the application for review was late. With their application for review, claimant included their response to the appellant questionnaire attached to Order No. 24-UI-249094. EAB Exhibit 1. However, claimant's response to the appellant questionnaire addressed only their late request for hearing on the January 24, 2024, Wage and Potential Benefits Report. It did not describe the circumstances that prevented claimant from filing their application for review of Order No. 24-UI-249094 on time. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed April 12, 2024, is dismissed. Order No. 24-UI-249094 remains undisturbed.
