EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0343

Affirmed
Late Request to Reopen Allowed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On July 2, 2021, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report (WPBR) concluding that claimant was monetarily eligible to receive Pandemic Emergency Unemployment Compensation (PEUC) benefits with a weekly benefit amount of \$151 and maximum benefit of \$1,963. On July 12, 2021, the July 2, 2021 WPBR became final without claimant having filed a request for hearing. On July 21, 2021, claimant filed a late request for hearing on the July 12, 2021 WPBR.

On September 19, 2023, notice was mailed to claimant that a hearing was scheduled for October 3, 2023. Claimant failed to appear at the hearing, and on October 3, 2023, ALJ Roberts issued Order No. 23-UI-237507, dismissing claimant's request for hearing due to his failure to appear. On October 23, 2023, Order No. 23-UI-237507 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 27, 2023, claimant filed a late request to reopen the October 3, 2023 hearing. On March 7, 2024, ALJ Lucas conducted a hearing, and on March 15, 2024 issued Order No. 24-UI-250153, allowing claimant's late request to reopen the October 3, 2023 hearing, canceling Order No. 23-UI-237507, dismissing claimant's request for hearing as late without good cause, and leaving the July 2, 2021 WPBR undisturbed. On April 4, 2024, claimant filed an application for review of Order No. 24-UI-250153 with EAB.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-250153's findings of fact, reasoning, and conclusions that good cause was shown to reopen the October 3, 2023, hearing, but that good cause was not shown to allow claimant's late request for hearing. Pursuant to ORS 657.275(2), Order No. 24-UI-250153 is **adopted**.

¹ The hearing record suggests that claimant did not actually disagree with the WPBR or desire a hearing to contest it, but instead filed his request in order to alert the Department that he had become able to work and was actively seeking work after having previously been found ineligible for benefits while he was unable to work and not actively seeking work due to an injury. *See* Exhibit 2 at 1-3, 5. The Department's records show that the Department ultimately ended the period of ineligibility retroactively **and in November 2021 paid claimant all of the PEUC benefits he had claimed.** It is therefore unlikely a justiciable controversy would exist had the late request for hearing been allowed.

DECISION: Order No. 24-UI-250153 is affirmed.
