# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0356

### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 3, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the weeks including August 20 through September 16, 2023, September 24 through September 30, 2023, October 8 through October 14, 2023, and October 22 through October 28, 2023, and was denied for those weeks and until the reason for the denial ended (decision # 83428). Claimant filed a timely request for hearing. On November 20, 2023, the Office of Administrative Hearings (OAH) served notice that a hearing was scheduled for December 4, 2023. On December 4, 2023, claimant failed to appear for the hearing, and on December 8, 2023, ALJ Lucas issued Order No. 23-UI- 242993, dismissing claimant's request for hearing due to his failure to appear, leaving decision # 83428 undisturbed.

On December 11, 2023, claimant filed a timely request to reopen the December 4, 2023, hearing. On February 12, 2024, OAH served notice of a hearing scheduled for March 11, 2024, on whether to grant claimant's request to reopen the December 4, 2023, hearing and, if so, the merits of decision # 83428. On March 11, 2024, ALJ Lucas conducted the hearing, and on March 18, 2024, issued Order No. 24-UI-250245, denying claimant's request to reopen the December 4, 2023, hearing, leaving Order No. 23-UI-242993 undisturbed. On April 8, 2024, Order No. 24-UI-250245 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 9, 2024, claimant filed a late application for review of Order No. 24-UI-250245 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review and written statement, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-250245, mailed to claimant on March 18, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment

Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-250245 at 5. Order No. 24-UI-250245 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 8, 2024, to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-250245 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-250245 was due April 8, 2024. Because claimant did not file his application for review until April 9, 2024, the application for review was late. EAB Exhibit 1. Claimant provided a written statement with the application for review. EAB Exhibit 1. However, claimant's written statement did not describe circumstances preventing claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

**DECISION:** The application for review filed April 9, 2024, is dismissed. Order No. 24-UI-250245 remains undisturbed.
