

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0359

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 15, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from January 28 through February 10, 2024, and until claimant provided information on why they did not return to work by February 12, 2024 (decision # 55619). Claimant filed a timely request for hearing. On March 25, 2024, ALJ Chiller conducted a hearing, and on March 27, 2024, issued Order No. 24-UI-251037, reversing decision # 55619 by concluding that claimant did not fail to furnish the information and was eligible for benefits for the weeks from January 28 through February 10, 2024 (weeks 05-24 through 06-24). On April 9, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 24-UI-251037 presents no justiciable controversy and is dismissed.

On April 9, 2024, claimant filed with the Employment Appeals Board (EAB) an application for review of an order that allowed the appellant (claimant) benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 24-UI-251037 is dismissed and Order No. 24-UI-251037 remains undisturbed.

DECISION: The application for review filed April 9, 2024, is dismissed. Order No. 24-UI-251037 remains undisturbed.
