EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0361

Affirmed
Entitled to Minimum PUA Weekly Benefit Amount of \$205

PROCEDURAL HISTORY: On February 19, 2021, the Oregon Employment Department (the Department) served notice of a determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was entitled to the minimum PUA weekly benefit amount of \$205, effective February 2, 2020. On March 11, 2021, the PUA determination became final without claimant having requested a hearing. On February 25, 2024, claimant filed a late request for hearing. On March 6, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing on whether to allow claimant's late request for hearing and, if so, the merits of the PUA determination. On March 20, 2024, ALJ Fraser conducted the hearing, and on March 21, 2024, issued Order No. 24-UI-250639, allowing claimant's late request for hearing and affirming the PUA determination by concluding that claimant was only entitled to the minimum PUA weekly benefit amount of \$205 from February 2, 2020, through December 12, 2020, December 12, 2020 through January 2, 2021, and January 10, 2021 through September 4, 2021. On April 10, 2024, claimant filed an application for review of Order No. 24-UI-250639 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: With his application for review, claimant requested that EAB consider additional evidence. Under OAR 471-041-0090(1)(a), any party may request that EAB consider additional evidence, and EAB may allow such a request when the party offering the additional evidence establishes that the additional evidence is relevant and material to EAB's determination, and that factors or circumstances beyond the party's reasonable control prevented the party from offering the additional evidence into the hearing record. Here, claimant established that factors or circumstances beyond his reasonable control prevented him from offering the additional evidence into the hearing record. However, claimant did not submit the additional evidence he is asking EAB to consider, and therefore failed to establish that the additional evidence is relevant and material to EAB's determination of whether claimant is entitled to more than the only entitled to the minimum PUA weekly benefit amount of \$205 during the periods at issue. Claimant's request that EAB consider the additional evidence therefore is denied.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-250639's findings of fact, reasoning, and conclusion that claimant was only entitled to the minimum PUA weekly benefit amount of \$205 during the periods at issue. Pursuant to ORS 657.275(2), Order No. 24-UI-250639 is **adopted**.

DECISION: Order No. 24-UI-250639 is affirmed.
