

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0362

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of December 24 through December 30, 2023, because claimant did not report their earnings for that week as instructed. Claimant filed a timely request for hearing. On February 21, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 28, 2024. On February 28, 2024, claimant failed to appear at the hearing, and on February 29, 2024, ALJ Roberts issued Order No. 24-UI-249170, dismissing claimant's request for hearing due to the failure to appear. On March 5, 2024, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on April 4, 2024, issued Order No. 24-UI-251586, concluding that the request was denied because claimant failed to show good cause for failing to appear at the hearing, leaving Order No. 24-UI-249170 undisturbed. On April 10, 2024, claimant filed an application for review of Order No. 24-UI-251586 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251586's findings of fact, reasoning, and denial of claimant's request to reopen the February 28, 2024, hearing. Pursuant to ORS 657.275(2), Order No. 24-UI-251586 is **adopted**.

DECISION: Order No. 24-UI-251586 is affirmed.
