EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0364

Applications for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 26, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of December 3 through 9, 2023 (week 49-23) and until the reason for the denial ended. Also on December 26, 2023, the Department issued an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits for week 49-23 and until the reason for the denial ended (decision # 94046). On January 16, 2024, both administrative decisions became final without claimant having filed requests for hearing.

On January 25, 2024, claimant filed late requests for hearing on both administrative decisions. ALJ Kangas considered claimant's requests, and on January 31, 2024, issued Orders No. 24-UI-247020 and 24-UI-247009, dismissing claimant's requests for hearing on the administrative decisions as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by February 14, 2024. On February 20, 2024, Orders No. 24-UI-247020 and 24-UI-247009 became final without claimant having filed a response to the appellant questionnaire or applications for review with the Employment Appeals Board (EAB). On April 10, 2024, claimant filed late applications for review of Orders No. 24-UI-247020 and 24-UI-247009 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-247020 and 24-UI-247009. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0364 and 2024-EAB-0365).

CONCLUSIONS AND REASONS: The applications for review are dismissed without prejudice.

On April 10, 2024, the appellant filed applications for review of Orders No. 24-UI-247020 and 24-UI-247009 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than February 20, 2024. The appellant's applications for review are therefore late, and are dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late applications for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is May 23, 2024, and
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, and
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's orders that were mailed January 31, 2024, whether they read them, whether they agreed or disagreed with the ALJ's orders, the reason(s) why they did not file the applications for review before the deadline, how the reason(s) affected their ability to file timely applications for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing timely applications for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing timely applications for review (which they listed in response to #3, above) ended, and
- 5. The appellant must provide sufficient information to prove that they filed their applications for review within seven days of that date.

Further, the record presently contains no information as to why claimant's requests for hearing on the two administrative decisions issued December 26, 2023 were not filed by the January 16, 2024 deadline. Claimant should therefore also explain with their request for reconsideration why their requests for hearing on these two administrative decisions were filed late, using the same criteria listed above. Depending on the circumstances, EAB may consider this additional information if claimant's late applications for review are allowed on reconsideration.

The appellant may file a request for reconsideration in many ways; please note that you need only file one request for reconsideration:

DECISION: The applications for review filed April 10, 2024 are dismissed without prejudice. Orders No. 24-UI-247020 and 24-UI-247009 remain undisturbed.
