

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0366**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On February 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and that claimant was disqualified from receiving benefits effective November 26, 2023 (decision # 135300). Claimant filed a timely request for hearing. On March 27, 2024, ALJ Mellor conducted a hearing, and on March 29, 2024, issued Order No. 24-UI-251208, reversing decision # 135300 by concluding claimant was discharged, but not for misconduct, and not disqualified from receiving benefits based on the work separation. On April 11, 2024, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251208's findings of fact, reasoning, and conclusion that claimant's discharge was not for misconduct. Pursuant to ORS 657.275(2), Order No. 24-UI-251208 is **adopted**.

**DECISION:** Order No. 24-UI-251208 is affirmed.
