EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0374

Affirmed No Disqualification

PROCEDURAL HISTORY: On November 3, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective August 27, 2023 (decision # 145045). Claimant filed a timely request for hearing. However, the Department did not recognize claimant's hearing request as having been filed.

Because claimant's timely hearing request was not recognized as having been filed, on November 23, 2023, decision # 145045 was construed as having become final without claimant having filed a request for hearing. On December 6, 2023, claimant filed another request for hearing, which was construed as claimant's only request for hearing on decision # 145045, and because it was filed after November 23, 2023, was viewed as a late request for hearing. ALJ Kangas considered claimant's December 6, 2023, request, and on December 19, 2023, issued Order No. 23-UI-243781, dismissing claimant's December 6, 2023, request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 2, 2024. On December 22, 2023, claimant filed a timely response to the appellant questionnaire and a timely application for review with the Employment Appeals Board (EAB). On February 12, 2024, ALJ Kangas mailed a letter to claimant stating that the Office of Administrative Hearings (OAH) considered the appellant questionnaire response to have been filed late, on January 29, 2024, and therefore it would not be considered and another order would not be issued regarding the matter. On February 29, 2024, EAB issued EAB Decision 2024-EAB-0140, reversing Order No. 23-UI-243781 and remanding the matter for a hearing to determine whether claimant's December 6, 2023 late request for hearing should be allowed and, if so, the merits of decision # 145045.

On March 27, 2024, ALJ Adamson conducted a hearing, and on March 28, 2024, issued Order No. 24-UI-251088, allowing claimant's first hearing request as timely and reversing decision # 145045 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On April 16, 2024, the employer filed an application for review with EAB.

WRITTEN ARGUMENT: The employer filed a written argument with EAB but did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. See ORS 657.275(2).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251088's findings of fact, reasoning, and conclusion that claimant's first hearing request was timely filed and that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. Pursuant to ORS 657.275(2), Order No. 24-UI-251088 is **adopted**.

DECISION: Order No. 24-UI-251088 is affirmed.
