

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0378

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 22, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective April 2, 2023 (decision # 85643). On July 12, 2023, decision # 85643 became final without claimant having filed a request for hearing. On August 26, 2023, claimant filed a late request for hearing on decision # 85643. ALJ Kangas considered claimant's request, and on September 26, 2023, issued Order No. 23-UI-236833, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 10, 2023.

On October 9, 2023, claimant filed a timely response to the appellant questionnaire. On February 2, 2024, the Office of Administrative Hearings (OAH) mailed the parties a letter stating that based on claimant's response, Order No. 23-UI-236833 was vacated and that a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 85643. On April 1, 2024, ALJ Chiller conducted a hearing, and on April 8, 2024, issued Order No. 24-UI-251741, dismissing claimant's request for hearing as not filed within a reasonable time, leaving decision # 85643 undisturbed. On April 19, 2024, claimant filed an application for review of Order No. 24-UI-251741 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251741's findings of fact, reasoning, and dismissal of claimant's late request for hearing as not filed within a reasonable time. Pursuant to ORS 657.275(2), Order No. 24-UI-251741 is **adopted**.

DECISION: Order No. 24-UI-251741 is affirmed.
