

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0380

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On December 28, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information to the Department and was not eligible for benefits for the weeks from December 10 through 23, 2023 and until claimant provided the requested information (decision # 94534). Claimant filed a timely request for hearing. On January 18, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 29, 2024. On January 29, 2024, claimant failed to appear at the hearing, and on January 30, 2024, ALJ Frank issued Order No. 24-UI-246862, dismissing claimant's request for hearing for failing to appear. On February 20, 2024, Order No. 24-UI-246862 became final without claimant having filed a request to reopen the hearing. On April 5, 2024, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on April 10, 2024, issued Order No. 24-UI-251936, denying the request as late without a showing of good cause, leaving Order No. 24-UI-246862 undisturbed. On April 20, 2024, claimant filed an application for review of Order No. 24-UI-251936 with EAB.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251936's findings of fact, reasoning, and conclusion that claimant's request to reopen the hearing was late without good cause, leaving claimant's request for hearing dismissed and decision # 94534 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-251936 is **adopted**.

DECISION: Order No. 24-UI-251936 is affirmed.
