EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0395

This decision concludes that claimant's application for review is dismissed because Order No. 24-UI-251876 was in claimant's favor, concluding that claimant did not have to repay the \$6,327 in PEUC and \$7,500 in FPUC benefits claimant received, and the Department could not deduct the benefits from any future benefits payable. Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 1, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that due to the Department's error, claimant received \$6,327 in Pandemic Emergency Unemployment Compensation (PEUC) and \$7,500 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which claimant was not entitled and must repay by having the benefits deducted from any benefits payable for a period three years (decision # 73525). Claimant filed a timely request for hearing. On April 9, 2024, ALJ Goodrich conducted a hearing that was interpreted into Vietnamese, and on April 10, 2024, issued Order No. 24-UI-251876, reversing decision # 73525 by concluding that claimant did not have to repay the benefits, and the Department could not deduct the benefits from any future benefits payable. On April 16, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 24-UI-251876 presents no justiciable controversy and is dismissed.

On April 16, 2024, claimant filed with the Employment Appeals Board (EAB) an application for review of an order concluding that claimant did not have to repay the \$6,327 in PEUC and \$7,500 in FPUC benefits she received, and the Department could not deduct the benefits from any future benefits payable. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no

justiciable controversy, the application for review of Order No. 24-UI-251876 is dismissed and Order No. 24-UI-251876 remains undisturbed.

DECISION: The application for review filed April 16, 2024, is dismissed. Order No. 24-UI-251876 remains undisturbed.
