EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0402

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective January 19, 2020 (decision # 142852). On January 11, 2021, decision # 142852 became final without claimant having filed a request for hearing. On March 8, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 5, 2021, issued Order No. 21-UI-164178, dismissing claimant's the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 19, 2021. On April 26, 2021, Order No. 21-UI-164178 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On April 26, 2024, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-164178 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review of Order No. 21-UI-164178 with a handwritten statement and claimant's response to the appellant questionnaire, which has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: Order No. 21-UI-164178, mailed to claimant on April 5, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164178 at 2. Order No. 21-UI-164178 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 26, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-164178 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164178 was due April 26, 2021. Because claimant did not file their application for review until April 26, 2024, the application for review was three years late. Claimant provided a written statement with the application for review, including her appellant questionnaire response, which suggests she may not have received Order No. 21-UI-164178 until June 15, 2021. EAB Exhibit 1 at 2. If so, while claimant may have had good cause for the late application for review of Order No. 21-UI-164178, claimant failed to establish the late application for review was filed within seven days after the circumstances that prevented claimant from timely filing ended, and therefore failed to establish the late application for review was filed within a reasonable time. Accordingly, claimant's late application for review is dismissed.

DECISION: The application for review filed April 26, 2024, is dismissed. Order No. 21-UI-164178 remains undisturbed.
