# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0405

# Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On October 6, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning March 29, 2020, because claimant quit working for the employer without good cause (decision # 70709). On October 26, 2020, decision # 70709 became final without claimant having filed a request for hearing. On March 6, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 1, 2024, issued Order No. 24-UI-251246, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 15, 2024.

On April 22, 2024, Order No. 24-UI-251246 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 24-UI-251246 with the Employment Appeals Board (EAB). On April 24, 2024, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 24-UI-251246 with EAB. On May 1, 2024, ALJ Kangas mailed the parties a letter stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order on the matter would not be issued, and Order No. 24-UI-251246 remained in effect. This matter comes before EAB based on claimant's April 24, 2024, late application for review of Order No. 24-UI-251246.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review of Order No. 24-UI-251246, claimant's response to the appellant questionnaire, and the envelope in which they were mailed, which have been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDINGS OF FACT:** (1) Order No. 24-UI-251246, mailed to claimant on April 1, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment

Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-251246 at 2. Order No. 24-UI-251246 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 22, 2024."

(2) Claimant filed their application for review of Order No. 24-UI-251246 by mail. The postmark date on the envelope in which claimant mailed their application for review is April 24, 2024. EAB Exhibit 1 at 4.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-251246 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-251246 was due April 22, 2024. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review is April 24, 2024, which therefore is the filing date. EAB Exhibit 1 at 4. Because claimant did not file their application for review until April 24, 2024, the application for review was late.

Claimant's response to the appellant questionnaire attached to Order No. 24-UI-251246 suggests that claimant may not have received Order No. 24-UI-251246 until April 16, 2024. EAB Exhibit 1 at 2. However, the rest of claimant's response explains why claimant's late request for hearing on decision # 70709 was late, but not why claimant did not file their application for review of Order No. 24-UI-251246 by the April 22, 2024, deadline. EAB Exhibit 1 at 2-3. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed April 24, 2024, is dismissed. Order No. 24-UI-251246 remains undisturbed.
