

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0408**

*Affirmed*  
*Ineligible Weeks 52-23 and 1-24*

**PROCEDURAL HISTORY:** On January 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the claimant was ineligible for benefits for the week of December 24 through December 30, 2023, and until he registered for work as instructed. Claimant filed a timely request for hearing. On April 2, 2024, ALJ Chiller conducted a hearing, and on April 10, 2024, issued Order No. 24-UI-251933, modifying the administrative decision by concluding that claimant was ineligible for benefits for the weeks from December 24, 2023, through January 6, 2024 (weeks 52-23 and 1-24). On April 27, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered claimant's argument to the extent it was relevant and material, and based on the hearing record.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251933's findings of fact, reasoning, and conclusion that claimant was ineligible for benefits for weeks 52-23 and 1-24 because he failed to register for work as instructed. Pursuant to ORS 657.275(2), Order No. 24-UI-251933 is **adopted**.

**DECISION:** Order No. 24-UI-251933 is affirmed.
