EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0409

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 21, 2021, the Oregon Employment Department (the Department) served an Amended Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was entitled to only the minimum PUA weekly benefit amount. On July 12, 2021, the PUA determination became final without claimant having filed a request for hearing. On November 28, 2022, claimant filed a late request for hearing. ALJ Kangas considered the request, and on March 30, 2023, issued Order No. 23-UI-220592, dismissing the request as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire within 14 days.

Claimant filed a timely response to the appellant questionnaire. On January 24, 2024, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that based on claimant's appellant questionnaire response, Order No. 23-UI-220592 was vacated and a hearing would be scheduled on whether to allow claimant's late request for hearing and, if so, the merits of the PUA determination. On April 9, 2024, ALJ Janzen conducted the hearing, and on April 10, 2024, issued Order No. 24-UI-251890, re-dismissing claimant's late request for hearing as late without good cause, leaving the PUA determination undisturbed. On April 28, 2024, claimant filed an application for review of Order No. 24-UI-251890 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's argument when reaching this decision.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-251890's findings of fact, reasoning, and re-dismissal of claimant's late request for hearing as late without good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-251890 is **adopted**.

DECISION: Order No. 24-UI-251890 is affirmed.
