

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0410**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On December 5, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective October 1, 2023 (decision # 105153). Claimant filed a timely request for hearing. On December 21, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 5, 2024. On January 5, 2024, claimant failed to appear at the hearing, and ALJ Micheletti issued Order No. 24-UI-244877, dismissing claimant’s request for hearing due to her failure to appear. On January 25, 2024, Order No. 24-UI-244877 became final without claimant having filed a request to reopen the hearing.

On March 1, 2024, claimant filed a late request to reopen the hearing. On March 15, 2024, OAH served notice of a hearing scheduled for March 28, 2024, on whether to grant claimant’s request and, if so, the merits of decision # 105153. On March 28, 2024, ALJ Contreras conducted the hearing, and on April 1, 2024, issued Order No. 24-UI-251259, granting claimant’s request to reopen and reversing decision # 105153 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On April 22, 2024, Order No. 24-UI-251259 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On April 29, 2022, the employer filed a late application for review of Order No. 24-UI-251259 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of employer’s written statement submitted with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** Order No. 24-UI-251259 mailed to claimant on April 1, 2024, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 24-UI-251259 at 7. Order No.

24-UI-251259 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before April 22, 2024, to be timely.”

**CONCLUSIONS AND REASONS:** Employer’s late application for review of Order No. 24-UI-251259 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-251259 was due April 22, 2024. Because the employer did not file their application for review until April 29, 2024, the application for review was late. The employer provided a written statement with the application for review. However, employer’s written statement did not describe circumstances preventing them from filing the application for review on time. EAB Exhibit 1. Accordingly, the employer did not show good cause for the late application for review, and their late application for review is dismissed.

**DECISION:** The application for review filed April 29, 2024, is dismissed. Order No. 24-UI-251259 remains undisturbed.
