

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0418

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 20, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the week including December 3 through December 9, 2023, and was therefore not eligible to receive unemployment insurance benefits for that week and until the reason for the denial ended (decision # 122630). On January 9, 2024, decision # 122630 became final without claimant having filed a request for hearing. On February 2, 2024, claimant filed a late request for hearing on decision # 122630. ALJ Kangas considered claimant's request, and on February 9, 2024, issued Order No. 24-UI-247752, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 23, 2024. On February 22, 2024, claimant filed a timely response to the appellant questionnaire. On April 9, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 26, 2024, on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 122630. On April 26, 2024, ALJ Janzen conducted the hearing, and on April 29, 2024, issued Order No. 24-UI-253068, re-dismissing claimant's request for hearing on decision # 122630 as late without good cause and leaving decision # 122630 undisturbed. On May 8, 2024, claimant filed an application for review of Order No. 24-UI-253068 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision, including Exhibits 1 and 2. EAB considered claimant's argument to the extent it was based on the record.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-253068's findings of fact, reasoning, and conclusion that claimant's request for hearing was late without good cause and leaving decision # 122630 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-253068 is **adopted**.

DECISION: Order No. 24-UI-253068 is affirmed.
