# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0425

Affirmed No Disqualification

**PROCEDURAL HISTORY:** On April 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective March 5, 2023 (decision # 132641). On April 24, 2023, decision # 132641 became final without claimant having filed a request for hearing. On January 3, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 8, 2024, issued Order No. 24-UI-244909, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 22, 2024. On January 12, 2024, claimant filed a timely response to the appellant questionnaire. On February 26, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 24-UI-244909 was vacated and that a hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 132641. On April 23, 2024, ALJ Christon conducted a hearing, at which the employer failed to appear, and on April 24, 2024, issued Order No. 24-UI-252832, allowing claimant's late request for hearing and reversing decision # 132641 by concluding that claimant was discharged but not for misconduct and was not disqualified from receiving benefits based on the work separation. On May 6, 2024, the employer filed an application for review of Order No. 24-UI-252832 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer submitted a written argument with their application for review but did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). For these reasons, EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-252832's findings of fact, reasoning, and conclusion that claimant's late request for hearing should be allowed and the employer

discharged claimant, but not for misconduct, and that claimant is not disqualified from receiving benefits based on the work separation. Pursuant to ORS 657.275(2), Order No. 24-UI-252832 is **adopted**.

**DECISION:** Order No. 24-UI-252832 is affirmed.
