# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0431

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On February 19, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits because he was eligible for other unemployment insurance benefits. On March 11, 2021, the PUA determination became final without claimant having filed a request for hearing. On July 22, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 18, 2024, issued Order No. 24-UI-245793, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 1, 2024. On January 22, 2024, claimant filed a timely response to the appellant questionnaire.

On March 1, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 24-UI-245793 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of the PUA determination. On April 4, 2024, ALJ Frank conducted the hearing, and on April 11, 2024, issued Order No. 24-UI-252072, re-dismissing claimant's request for hearing as late without good cause, leaving the PUA determination undisturbed. On May 1, 2024, Order No. 24-UI-252072 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 8, 2024, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review which included a written argument, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-252072, mailed to claimant on April 11, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-252072 at 3.

Order No. 24-UI-252072 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 1, 2024, to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-252072 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-252072 was due May 1, 2024. Because claimant did not file their application for review until May 8, 2024, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed May 8, 2024, is dismissed. Order No. 24-UI-252072 remains undisturbed.
