

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0441

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 20, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective February 12, 2023 (decision # 92300). On April 10, 2023, decision # 92300 became final without claimant having filed a request for hearing. On February 22, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 1, 2024, issued Order No. 24-UI-249237, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 15, 2024. Claimant filed a response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on May 8, 2024, issued Order No. 24-UI-253720, re-dismissing claimant's request for hearing as late without good cause. On May 13, 2024, claimant filed an application for review of Order No. 24-UI-253720 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that the information was relevant and material to EAB's determination as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision.¹ See ORS 657.275(2).

EAB considered the entire hearing record. EAB agrees with Order No. Order No. 24-UI-253720's findings of fact, reasoning, and dismissal of claimant's late request for hearing on decision # 92300. Pursuant to ORS 657.275(2), Order No. 24-UI-253720 is **adopted**.

¹ Although EAB cannot consider claimant's written argument for these reasons, EAB nevertheless acknowledges claimant's confusion regarding the continued denial of her benefits, as outlined in her written argument. Department records suggest that the source of claimant's current denial of benefits is not decision # 92300 (the decision at issue in this matter), but another, more recently-issued administrative decision that is outside the scope of EAB's jurisdiction in this matter. EAB encourages claimant to contact the Department directly for clarification on the continued denial of benefits.

DECISION: Order No. 24-UI-253720 is affirmed.
