

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0443

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On August 9, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$846 in Regular Unemployment Insurance (Regular UI) and \$900 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay (decision # 150659). Claimant filed a timely request for hearing. On January 2, 2024, the Office of Administrative Hearings (OAH) served notice that the hearing was scheduled for January 23, 2024. On January 23, 2024, claimant failed to appear at the hearing, and ALJ Lucas issued Order No. 24-UI-246317, dismissing claimant's request for hearing because she failed to appear. On January 26, 2024, claimant filed a timely request to reopen the hearing. On March 29, 2024, OAH served notice of a hearing scheduled for April 17, 2024, on whether to allow claimant's request to reopen the hearing and, if so, the merits of decision # 150659. On April 17, 2024, ALJ Chiller conducted the hearing, and on May 1, 2024, issued Order No. 24-UI-253311 denying claimant's request to reopen the hearing and leaving Order No. 24-UI-246317 undisturbed. On May 13, 2024, claimant filed an application for review of Order No. 24-UI-253311 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-253311's findings of fact, reasoning, and denial of claimant's request to reopen the hearing on decision # 150659, leaving Order No. 24-UI-246317 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-253311 is **adopted**.

DECISION: Order No. 24-UI-253311 is affirmed.
