EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0447

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 24, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seeking work from April 2 through April 8, 2023 (week 14-23) and was not eligible for unemployment insurance benefits for that week. On May 15, 2023, the April 24, 2023, administrative decision became final without claimant having filed a request for hearing. On March 30, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 29, 2024, issued Order No. 24-UI-253133, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 13, 2024. Claimant did not file a response to the appellant questionnaire. On May 16, 2024, claimant filed a timely application for review of Order No. 24-UI-253133 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement regarding the late request for hearing and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) The April 24, 2023, administrative decision, mailed to claimant's address of record on file with the Department, stated, "IF YOU DO NOT AGREE WITH THIS DECISION, SEE THE ENCLOSED INFORMATION FOR YOUR APPEAL RIGHTS." Exhibit 1. The decision also stated, "Any appeal from this decision must be filed on or before MAY 15, 2023, to be timely." Exhibit 1. Claimant filed their request for hearing on March 30, 2024.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on the April 24, 2023, administrative decision was due by May 15, 2023. Because claimant filed their request for hearing on March 30, 2024, the request was late.

Claimant submitted a written statement regarding the late filing with their application for review. In that statement, claimant asserted that "other dismissals/denials were never received due to me becoming homeless and being unable to afford/obtain PO Box." EAB Exhibit 1 at 1. However, claimant stated that they updated their address with the Department on March 28, 2023, several weeks prior to the April 24, 2023, administrative decision being issued. EAB Exhibit 1 at 1. This suggests that claimant's receipt of the administrative decision would not have been affected by the address issue that may have prevented the timely receipt of other Department correspondence prior to March 28, 2023. The record does not contain an explanation *specific to the April 24, 2023, administrative decision* as to why claimant did not file a timely request for hearing. Claimant therefore has not shown that they were prevented from timely filing by a factor beyond their reasonable control or an excusable mistake. Accordingly, good cause has not been shown to extend the deadline for a timely filing.

For these reasons, claimant's late request for hearing on the April 24, 2023, administrative decision is dismissed. The April 24, 2023, administrative decision remains undisturbed.

DECISION: Order No. 24-UI-253133 is affirmed.
