

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0457**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On December 12, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective October 29, 2023 (decision # 62751). Claimant filed a timely request for hearing. On January 3, 2024, the Office of Administrative Hearings (OAH) served notice that the hearing was scheduled for January 18, 2024. On January 18, 2024, claimant failed to appear at the hearing, and on January 19, 2024, ALJ Adamson issued Order No. 24-UI-246006, dismissing claimant’s request for hearing because of the failure to appear. On February 8, 2024, Order No. 24-UI-246006 became final without claimant having filed a request to reopen the hearing.

On February 10, 2024, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant’s request, and on February 23, 2024, issued Order No. 24-UI-248726, dismissing the request as late without a showing of good cause, leaving Order No. 24-UI-246006 undisturbed. On March 14, 2024, Order No. 24-UI-248726 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 24, 2024, claimant filed a late application for review of Order No. 24-UI-248726 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence the written statement claimant included with their application for review of Order No. 24-UI-248726, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-248726, mailed to claimant on February 23, 2024, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 24-UI-248726 at 4. Order No. 24-UI-248726 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before March 14, 2024, to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 24-UI-248726 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-248726 was due March 14, 2024. Because claimant did not file their application for review until May 24, 2024, the application for review was late. Claimant provided a written statement with the application for review. EAB Exhibit 1. However, claimant’s written statement did not describe circumstances preventing claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and the late application for review is dismissed.

**DECISION:** The application for review filed May 24, 2024, is dismissed. Order No. 24-UI-248726 remains undisturbed.
