

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0460

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 22, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$1,230 in Pandemic Unemployment Assistance (PUA) and \$1,500 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled because she failed to report earnings, and which she must repay by having the benefits deducted from any benefits payable during a period of three years (decision # 143237). On October 12, 2022, decision # 143237 became final without claimant having filed a request for hearing.

On July 16, 2023, claimant filed a late request for hearing on decision # 143237. ALJ Scott considered claimant's request, and on January 18, 2024, issued Order No. 24-UI-245895, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire. Claimant filed a response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on May 7, 2024, issued Amended Order No. 24-UI-253620, re-dismissing claimant's late request for hearing on decision # 143237 as not filed within a reasonable time, leaving decision # 143237 undisturbed. On May 28, 2024, claimant filed a timely application for review of Amended Order No. 24-UI-253620 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB considered the entire hearing record. EAB agrees with Amended Order No. 24-UI-253620's findings of fact, reasoning, and dismissal of claimant's late request for hearing on decision # 143237 as not filed within a reasonable time, leaving decision # 143237 undisturbed. Pursuant to ORS 657.275(2), Amended Order No. 24-UI-253620 is **adopted**.

DECISION: Amended Order No. 24-UI-253620 is affirmed.
