EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0461

Affirmed
Ineligible for Pandemic Unemployment Assistance
Overpayment and Penalties

PROCEDURAL HISTORY: On October 6, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible for PUA benefits effective March 15, 2020. On October 14, 2022, the Department served notice of an administrative decision based in part on the PUA determination, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$31,325 in combined PUA and Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, and a \$4,698.75 monetary penalty. Claimant filed timely requests for hearing on both administrative decisions. On April 24, 2024, ALJ Chiller conducted a hearing on the PUA determination. On April 26, 2024, ALJ Chiller issued Orders No. 24-UI-253778 and 24-UI-253777, affirming the PUA determination and the overpayment decision. On May 28, 2024, claimant filed applications for review of Orders No. 24-UI-253778 and 24-UI-253777 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-253778 and 24-UI-253777. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0461 and 2024-EAB-0462).

WRITTEN ARGUMENT: Claimant filed written arguments on July 2, 2024 and July 8, 2024. Because claimant's July 8, 2024 argument was not received by EAB within the time period allowed under OAR 471-041-0080(1) (May 13, 2019), the argument was not considered by EAB when reaching this decision. OAR 471-041-0080(2)(b). Claimant's July 2, 2024 argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into

evidence at the hearing when reaching this decision. EAB considered claimant's July 2, 2024 argument to the extent it was based on the record.

EAB considered both hearing records. EAB agrees with Order No. 24-UI-253778's findings of fact, reasoning, and conclusion that claimant was not eligible for PUA benefits, and Order No. 24-UI-253777's findings of fact, reasoning, and conclusion that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and is liable for an overpayment of benefits and a monetary penalty. Pursuant to ORS 657.275(2), Orders No. 24-UI-253778 and 24-UI-253777 are **adopted**.

DECISION: Orders No. 24-UI-253778 and 24-UI-253777 are affirmed.
