

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0463

Affirmed
Request for Hearing Allowed
Ineligible for Pandemic Unemployment Assistance

PROCEDURAL HISTORY: On October 29, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible to receive PUA benefits effective April 26, 2020. On November 5, 2021, claimant filed a request for hearing that the Department failed to process. On November 18, 2021, the October 29, 2021 PUA determination became final without the Department having processed a request for hearing from claimant. On June 9, 2022, the Department forwarded claimant's request for hearing, which was construed as a late request for hearing. ALJ Kangas considered claimant's request, and on September 22, 2022 issued Order No. 22-UI-203360, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 6, 2022. On October 6, 2022, claimant filed a timely response to the appellant questionnaire. On March 2, 2023, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-203360 was vacated and that a hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the October 29, 2021 PUA determination. On May 2, 2024, ALJ Chiller conducted a hearing that was interpreted in Arabic, and on May 14, 2024 issued Order No. 24-UI-254127, allowing claimant's November 5, 2021 request for hearing as timely, and affirming the October 29, 2021 PUA determination on the merits. On May 28, 2024, claimant filed an application for review of Order No. 24-UI-254127 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-254127's findings of fact, reasoning, and conclusions that claimant's request for hearing was timely filed, and that claimant was not eligible for PUA benefits. Pursuant to ORS 657.275(2), Order No. 24-UI-254127 is **adopted**.

DECISION: Order No. 24-UI-254127 is affirmed.
