

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0470**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On April 2, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective November 19, 2023 (decision # L0003421012). Claimant filed a timely request for hearing. On May 17, 2024, ALJ Mellor conducted a hearing, and on May 24, 2024, issued Order No. 24-UI-255035, reversing decision # L0003421012 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On May 29, 2024, the employer filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** The employer's argument included a request for EAB to consider additional evidence but did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the additional evidence into the hearing record, as required under OAR 471-041-0090(1)(b)(B) (May 13, 2019). The employer's request for EAB to consider the additional evidence therefore is denied. EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered the employer's argument to the extent it was based on the hearing record.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-255035's findings of fact, reasoning, and conclusion that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. Pursuant to ORS 657.275(2), Order No. 24-UI-255035 is **adopted**.

**DECISION:** Order No. 24-UI-255035 is affirmed.
