

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0472

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 10, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning September 10, 2023, because claimant was discharged by the employer for misconduct (decision # 63228). Claimant filed a timely request for hearing. On February 7, 2024, the Office of Administrative Hearings (OAH) served notice that a hearing was scheduled for February 21, 2024. On February 21, 2024, claimant failed to appear at the hearing, and ALJ Nyberg issued Order No. 24-UI-248558, dismissing claimant's request for hearing due to his failure to appear, leaving decision # 63228 undisturbed.

On March 12, 2024, claimant filed a timely request to reopen the February 21, 2024, hearing. On April 24, 2024, OAH served notice that a hearing was scheduled for May 8, 2024, on whether to grant claimant's request to reopen and, if so, the merits of decision # 63228. On May 8, 2024, ALJ Contreras conducted the hearing, and on May 9, 2024, issued Order No. 24-UI-253874, denying claimant's request to reopen as without good cause, leaving Order No. 24-UI-248558 and decision # 63228 undisturbed. On May 29, 2024, claimant filed a timely application for review of Order No. 24-UI-253874 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: Claimant submitted additional evidence with his application for review. EAB did not consider the evidence because it is not relevant to EAB's determination of whether to claimant's request to reopen the February 21, 2024, hearing should have been granted. OAR 471-041-0090(1) (May 13, 2019).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-253874's findings of fact, reasoning, and denial of claimant's request to reopen as without good cause, leaving Order No. 24-UI-248558 and decision # 63228 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-253874 is **adopted**.

DECISION: Order No. 24-UI-253874 is affirmed.
