

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0475

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 22, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the weeks including January 28 through February 10, 2024 (weeks 05-24 through 06-24) and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 153022). On March 13, 2024, decision # 153022 became final without claimant having filed a request for hearing. On March 15, 2024, claimant filed a late request for hearing on decision # 153022. ALJ Kangas considered claimant's request, and on April 9, 2024, issued Order No. 24-UI-251773, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 23, 2024. On April 19, 2024, claimant filed a timely response to the appellant questionnaire. On April 30, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 14, 2024, on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 153022. On May 14, 2024, ALJ Enyinnaya conducted the hearing, and on May 17, 2024, issued Order No. 24-UI-254454, re-dismissing claimant's request for hearing on decision # 153022 as late without good cause and leaving decision # 153022 undisturbed. On May 30, 2024, claimant filed an application for review of Order No. 24-UI-254454 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-254454's findings of fact, reasoning, and conclusion that claimant's request for hearing was late without good cause and leaving decision # 153022 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-254454 is **adopted**.

DECISION: Order No. 24-UI-254454 is affirmed.
