

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0478**

*Application for Review Dismissed*

**PROCEDURAL HISTORY:** On September 13, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$342 in benefits to which they were not entitled and must repay (decision # 195853). On October 3, 2022, decision # 195853 became final without claimant having filed a request for hearing. On March 22, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 1, 2024, issued Order No. 24-UI-253274, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 15, 2024. On May 21, 2024, Order No. 24-UI-253274 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On May 31, 2024, claimant filed an application for review with EAB.

**FINDING OF FACT:** (1) Order No. 24-UI-253274, mailed to claimant on May 1, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-253274 at 2. Order No. 24-UI-253274 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 21, 2024."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-253274 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-253274 was due May 21, 2024. Because claimant did not file their application for review until May 31, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the May 21, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed May 31, 2024, is dismissed. Order No. 24-UI-253274 remains undisturbed.
