EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0480

Reversed Request for Hearing Allowed Merits Hearing Required

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 29, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was therefore ineligible for unemployment insurance benefits effective March 28, 2024, and until the reason for the denial ended (decision # L0003464730). Claimant filed a timely request for hearing. On or around May 28, 2024, claimant withdrew their request for hearing. On May 28, 2024, ALJ Mellor issued Order No. 24-UI-255096, dismissing claimant's request for hearing because claimant withdrew the request. On June 3, 2024, claimant filed an application for review of Order No. 24-UI-255096 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of a May 28, 2024, Office of Administrative Hearings (OAH) memorandum regarding claimant's withdrawal of their request for hearing, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

CONCLUSIONS AND REASONS: Order No. 24-UI-255096 is set aside, and claimant is entitled to a hearing on the merits of decision # L0003464730.

Under ORS 657.270(7)(a) and OAR 471-040-0035(1) (August 1, 2004), an administrative law judge may order that a request for hearing be dismissed if the request has been withdrawn by the party who filed the request.

Claimant filed a timely request for hearing on decision # L0003464730, but withdrew the request on or around May 28, 2024, leading to the dismissal of claimant's hearing request. The record shows that claimant reported to OAH that they were withdrawing the request because the Department notified claimant that they were "eligible for benefits." EAB Exhibit 1 at 1. In their written argument, however, claimant explained:

The end of May 2024 I was notified of a review on my claim of March 30th, 2024. I had received a letter the week prior that I was entitled to my unemployment for the March 30 claim. Not wanting to needlessly take up the reviewer's time I called the number provided and withdrew my claim thinking I had been approved. I have since learned my unemployment has been cancelled because I withdrew. I am asking to be reinstated for my hearing.

Claimant's Written Argument at 1. This explanation, and the contents of the May 28, 2024, memorandum, suggest that claimant's initial decision to withdraw their request for hearing was premised on misleading information they received from the Department, or a misunderstanding of that information, and that claimant would not have withdrawn their request if they were aware of the effects of withdrawing the request. Because claimant withdrew their request apparently without an understanding of the facts regarding their eligibility or the effects of withdrawing the request, claimant's withdrawal should not be given effect. Therefore, claimant's request for hearing is allowed, and claimant is entitled to a hearing on the merits of decision # L0003464730.

DECISION: Order No. 24-UI-255096 is set aside, and this matter remanded for further proceedings consistent with this order.
