## EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0483

Affirmed Ineligible Week 13-24

**PROCEDURAL HISTORY:** On March 29, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to the Department and was ineligible for benefits effective March 24, 2024 (decision # L0003359380). Claimant filed a timely request for hearing. On May 23, 2024, ALJ Mellor conducted a hearing, and on May 31, 2024, issued Order No. 24-UI-255470, affirming decision # L0003359380 by concluding that claimant had failed to provide information to the Department and was ineligible for benefits for the week of March 24 through 30, 2024 (week 13-24). On June 4, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant filed written arguments on June 4 and 7, 2024. Both of claimant's arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing, or that the information is relevant and material to EAB's determination. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's arguments to the extent they were based on the record.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-255470's findings of fact, reasoning, and conclusion that claimant had failed to provided information to the Department and was

Order No. 24-UI-255470 at 1. Therefore, it is presumed that the Department intended to deny claimant benefits beginning the first day of that week, which was March 24, 2024.

ineligible for benefits for week 13-24. Pursuant to ORS 657.275(2), Order No. 24-UI-255470 is **adopted**.

**DECISION:** Order No. 24-UI-255470 is affirmed.
