

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0487

Affirmed
Disqualification

PROCEDURAL HISTORY: On December 26, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective August 27, 2023 (decision # 143235). Claimant filed a timely request for hearing. On February 12, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 27, 2024. On February 27, 2024, claimant failed to appear for the hearing, and ALJ S. Lee issued Order No. 24-UI-248924 dismissing claimant's request for hearing for failure to appear. On March 18, 2024, Order No. 24-UI-248924 became final without claimant having filed a request to reopen the hearing. On March 27, 2024, claimant filed a late request to reopen the hearing. On May 6 and 23, 2024, ALJ Strauch conducted a hearing, and on May 31, 2024, issued Order No. 24-UI-255413, allowing claimant's late request to reopen the hearing and affirming decision # 143235. On June 4, 2024, claimant filed an application for review of Order No. 24-UI-255413 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-255413's findings of fact, reasoning, decision to allow claimant's late request to reopen, and conclusion that claimant quit working for the employer without good cause. Pursuant to ORS 657.275(2), Order No. 24-UI-255413 is **adopted**.

DECISION: Order No. 24-UI-255413 is affirmed.
