# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0488

Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 9, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of October 22, 2023, through October 28, 2023 (week 43-23) and until the reason for the denial ended. On November 29, 2023, the November 9, 2023, administrative decision became final without claimant having filed a request for hearing. On December 30, 2023, claimant filed a late request for hearing. ALJ Kangas considered the request, and on January 18, 2024, issued Order No. 24-UI-245795, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 1, 2024. On January 24, 2024, claimant filed a timely response to the appellant questionnaire. ALJ Scott considered the response, and on March 22, 2024, issued Order No. 24-UI-250720, canceling Order No. 24-UI-245795 and re-dismissing claimant's request for hearing as late, subject to claimant's opportunity to provide additional information about the request by April 5, 2024. On April 11, 2024, Order No. 24-UI-250720 became final without claimant having provided additional information to the Office of Administrative Hearings (OAH) or filing an application for review with the Employment Appeals Board (EAB). On June 4, 2024, claimant filed a late application for review of Order No. 24-UI-250720 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the explanation for late filing provided with the application for review and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On June 4, 2024, the appellant filed an application for review of Order No. 24-UI-250720 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 11, 2024. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

Claimant's January 24, 2024, appellant questionnaire response appeared to refer to a different administrative decision than the one at issue in this appeal. Exhibit 3 at 1-2. It is important when making a request for reconsideration that claimant explain why their application for review and request for hearing were late with regard to **Order No. 24-UI-250720** and the **November 9, 2023, administrative decision** which concluded that claimant failed to register for work.

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is July 9, 2024, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

Claimant should also *separately* explain why their request for hearing on the November 9, 2023, work registration administrative decision was not filed by the November 29, 2023, appeal deadline for that decision.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

**DECISION:** The application for review filed June 4, 2024, is dismissed without prejudice. Order No. 24-UI-250720 remains undisturbed.
