EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0502

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 8, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$11,680 overpayment that claimant was required to repay to the Department, a \$1,752 monetary penalty, and a 52-week penalty disqualification from future benefits (decision # 195461). On October 28, 2020, decision # 195461 became final without claimant having filed a request for hearing. On June 2, 2023, claimant filed a late request for hearing on decision # 195461. ALJ Kangas considered claimant's request, and on November 6, 2023, issued Order No. 23-UI-240414, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 20, 2023. On November 27, 2023, Order No. 23-UI-240414 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On June 15, 2024, claimant filed a late application for review of Order No. 23-UI-240414 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's statement enclosed with the application for review, and a copy of the order under review (Order No. 23-UI-240414), which was returned to the Office of Administrative Hearings (OAH) as undeliverable. This evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: The application for review of Order No. 23-UI-240414 is dismissed without prejudice.

On June 15, 2024, claimant (the appellant) filed an application for review of Order No. 23-UI-240414 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no

later than November 27, 2023. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review with EAB may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is July 17, 2024, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review of Order No. 23-UI-240414. For example, the appellant should include specific information about whether they received Order No. 23-UI-240414, and if so, the date they received Order No. 23-UI-240414, whether they read it, whether they agreed or disagreed with Order No. 23-UI-240414, the reason(s) why they did not file the application for review before the deadline of November 27, 2023, how the reason(s) affected their ability to file a timely application for review, and if claimant never received a copy of Order No. 23-UI-240414, whether their failure to receive the order under review was the result of having moved, when they moved, when (if at all) they updated their address with the Department or the Office of Administrative Hearings after any such move, and any other specific details that might help EAB determine whether or not the appellant had "good cause" to extend the time to file the application for review; "good cause" means factors or circumstances beyond their reasonable control that prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or

DECISION: The application for review filed June 15, 2024, is dismissed without prejudice. Order No. 23-UI-240414 remains undisturbed.
