

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0510

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On November 9, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective August 27, 2023 (decision # 72231). Claimant filed a timely request for hearing. On November 27, 2023, notice was mailed to the parties that a hearing was scheduled for December 11, 2023. Claimant failed to appear for the hearing, and on December 13, 2023, ALJ Monroe issued Order No. 23-UI-243403, dismissing claimant's request for hearing due to his failure to appear. On January 2, 2024, Order No. 23-UI-243403 became final without claimant having filed a request to reopen the hearing. On May 30, 2024, claimant filed a late request to reopen the hearing. ALJ Kangas considered the request, and on June 5, 2024, issued Order No. 24-UI-255734, denying the request and leaving Order No. 23-UI-243403 undisturbed. On June 19, 2024, claimant filed an application for review of Order No. 24-UI-255734 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-255734's findings of fact, reasoning, and denial of claimant's late request to reopen the December 11, 2023, and leaving Order No. 23-UI-243403 undisturbed. Pursuant to ORS 657.275(2), Order No. 24-UI-255734 is **adopted**.

DECISION: Order No. 24-UI-255734 is affirmed.
