EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0521

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective August 30, 2020 (decision # 113258). Claimant filed a timely request for hearing. On October 5, 2021, ALJ Amesbury conducted a hearing at which the employer did not appear, and issued Order No. 21-UI-176428, affirming decision # 113258. On October 25, 2021, Order No. 21-UI-176428 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 5, 2024, claimant filed a late application for review of Order No. 21-UI-176428 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant included with their application for review, which has been marked as EAB Exhibit 1. Copies of EAB Exhibit 1 have been provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-176428, mailed to claimant on October 5, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-176428 at 3. Order No. 21-UI-176428 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 25, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 21-UI-176428 was late and therefore is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-176428 was due October 25, 2021. Because claimant did not file their application for review until June 5, 2024, the application for review was late. Claimant provided a written statement with their application for review. EAB Exhibit 1. However, the written statement did not explain why the application for review was not filed on time. EAB Exhibit 1. Accordingly, claimant did not show good cause to extend the deadline for filing the application for review, and the late application for review is dismissed.

DECISION: The application for review filed June 5, 2024 is dismissed. Order No. 21-UI-176428 remains undisturbed.
