

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0523**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On April 19, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits effective April 14, 2024<sup>1</sup> and until the reason for the denial ended (decision # L0003794745). Claimant filed a timely request for hearing. On May 29, 2024, notice was mailed to claimant that a hearing was scheduled for June 12, 2024. Claimant failed to appear for the hearing, and on June 13, 2024, ALJ Blam issued Order No. 24-UI-256440, dismissing claimant's request for hearing due to their failure to appear. On June 18, 2024, claimant filed a timely request to reopen the June 12, 2024, hearing. ALJ Kangas considered the request, and on June 24, 2024, issued Order No. 24-UI-257228, denying the request as without good cause and leaving Order No. 24-UI-256440 undisturbed. On July 1, 2024, claimant filed an application for review of Order No. 24-UI-257228 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's argument in reaching this decision.

EAB considered the entire hearing record. EAB agrees with Order No. 24-UI-257228's findings of fact, reasoning, and conclusion that claimant has not shown good cause to reopen the June 12, 2024, hearing. Pursuant to ORS 657.275(2), Order No. 24-UI-257228 is **adopted**.

**DECISION:** Order No. 24-UI-257228 is affirmed.
