EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0534

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 26, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for by the employer for misconduct and disqualified from receiving benefits effective December 10, 2023 (decision # 80643). On March 18, 2024, decision # 80643 became final without claimant having filed a request for hearing. On April 1, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 29, 2024, issued Order No. 24-UI-253138, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 13, 2024. On May 2, 2024, claimant filed a timely response to the appellant questionnaire. On May 9, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 24-UI-253138 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 80643.

On May 29 and 31, 2024, ALJ Mellor conducted a hearing, and on June 21, 2024, issued Order No. 24-UI-257102, allowing claimant's late request for hearing and affirming decision # 80643. On July 11, 2024, Order No. 24-UI-257102 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 15, 2024, claimant filed a late application for review of Order No. 24-UI-257102 with EAB.

FINDING OF FACT: (1) Order No. 24-UI-257102, mailed to claimant on June 21, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-257102 at 7. Order No. 24-UI-257102 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 11, 2024, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-257102 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-257102 was due by July 11, 2024. Because claimant did not file her application for review until July 15, 2024, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented her from filing the application for review by the July 11, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 15, 2024, is dismissed. Order No. 24-UI-257102 remains undisturbed.
