EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0539

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the week of June 13, 2021, through June 19, 2021 (week 24-21) and was therefore ineligible to receive unemployment insurance benefits for that week (decision # 95158). On December 13, 2021, decision # 95158 became final without claimant having filed a request for hearing. On July 10, 2022, claimant filed a late request for hearing. On June 18, 2024, ALJ Lucas conducted a hearing at which the employer failed to appear, and on June 21, 2024, issued Order No. 24-UI-257189, allowing claimant's late request for hearing and reversing decision # 95158 by concluding that claimant was available for work during week 24-21 and eligible to receive unemployment insurance benefits for that week. On July 11, 2024, Order No. 24-UI-257189 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On July 15, 2024, the employer filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the employer's statement and attached documents included with the late application for review and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 24-UI-257189, mailed to the employer on June 21, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-257189 at 7. Order No. 24-UI-257189 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 11, 2024, to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 24-UI-257189 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-257189 was due by July 11, 2024. Because the employer did not file their application for review until July 15, 2024, the application for review was late. The employer provided a written statement with the application for review. However, the employer's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed July 15, 2024, is dismissed. Order No. 24-UI-257189 remains undisturbed.
