EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0541

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On April 3, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving benefits effective February 25, 2024 (decision # L0003480580). On April 10, 2024, the Department served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits for the week of April 7 through 13, 2024 (week 15-24) and until the reason for the denial ended (decision # L0003568794). Claimant filed a timely request for hearing on each decision. On June 14, 2024, ALJ Christon conducted hearings on each administrative decision, and on June 21, 2024, issued Orders No. 24-UI-257138 and 24-UI-257194, affirming decisions # L0003480580 and L0003568794. On July 11, 2024, Orders No. 24-UI-257138 and 24-UI-257194 became final without claimant having filed an application for review with the Employment Appeals Board (EAB).

On July 16, 2024, claimant filed late applications for review of Orders No. 24-UI-257138 and 24-UI-257194 with EAB. Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-257138 and 24-UI-257194. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0541 and 2024-EAB-0542).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, the envelope in which it was mailed, and a statement regarding the filing, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

¹ Though decision # L0003568794 stated that the period of ineligibility began April 9, 2024, this date was a Tuesday, and because benefit weeks begin on Sunday, this is presumed to be a scrivener's error.

² Order No. 24-UI-257194 concluded that the reason for denial of benefits began and ended in week 15-24. Order No. 24-UI-257194 at 3. Therefore, it affirmed decision # L0003568794 because the decision did not specify any additional benefit weeks to which it applied.

FINDINGS OF FACT: (1) Orders No. 24-UI-257138 and 24-UI-257194, mailed to claimant on June 21, 2024, each stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-257138 at 4; Order No. 24-UI-257194 at 3. Orders No. 24-UI-257138 and 24-UI-257194 also each stated on their Certificate of Mailing, "Any appeal from this Order must be filed on or before July 11, 2024 to be timely."

(2) Claimant filed an application for review of Orders No. 24-UI-257138 and 24-UI-257194 by mail, and the envelope containing the application was postmarked July 16, 2024. EAB Exhibit 1 at 2. The submission was stamped received by EAB on July 18, 2024. EAB Exhibit 1 at 1.

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 24-UI-257138 and 24-UI-257194 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 24-UI-257138 and 24-UI-257194 were each due by July 11, 2024. Though claimant asserted in her written statement, "I mailed my Application for Review on 7.11.24," the envelope bears a postmark of July 16, 2024. EAB Exhibit 1 at 2-3. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The only potentially applicable exception is if the postmark date is "improbable," in which case EAB must determine "the most probable date of filing." OAR 471-041-0065(2). That the submission was received by EAB two days after the postmark date suggests that the envelope traveled in the ordinary course of the mail. The postmark date therefore is not "improbable." Under the rule, the applications for review of Orders No. 24-UI-257138 and 24-UI-257194 were filed July 16, 2024, and were therefore late.

Claimant's written statement did not otherwise suggest an explanation for the late filing. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

DECISION: The applications for review filed July 16, 2024 are dismissed. Orders No. 24-UI-257138 and 24-UI-257194 remain undisturbed.
