

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0548

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the work separation (decision # 90720). The employer filed a timely request for hearing. On September 13 and October 7, 2019, ALJ L. Lee conducted a hearing, and on October 15, 2019, issued Order No. 19-UI-138120, reversing decision # 90720 by concluding that claimant was discharged for misconduct and disqualified from receiving benefits effective July 14, 2019. On November 4, 2019, Order No. 19-UI-138120 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 22, 2024, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 19-UI-138120, mailed to claimant on October 15, 2019, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 19-UI-138120 at 7. Order No. 19-UI-138120 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before November 4, 2019, to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 19-UI-138120 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 19-UI-138120 was due by November 4, 2019. Because claimant did not file her application for review until July 22, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing her from filing the application for review by the November 4, 2019, deadline. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed July 22, 2024, is dismissed. Order No. 19-UI-138120 remains undisturbed.
