EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0552-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 16, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer, not for misconduct, within 15 days of a planned voluntarily leaving without good cause, and therefore was eligible for benefits for the week of January 21 through 27, 2024 (week 04-24), and disqualified from receiving benefits effective January 28, 2024 (decision # L0003641244). Claimant filed a timely request for hearing. On July 3, 2024, ALJ Christon conducted a hearing, and on July 17, 2024, issued Amended Order No. 24-UI-259273, affirming decision # L0003641244. On July 19, 2024, claimant filed an application for review with the Employment Appeals Board (EAB). On August 9, 2024, EAB issued EAB Decision 2024-EAB-0552, affirming Order No. 24-UI-259273. On August 21, 2024, claimant filed a request for reconsideration of EAB Decision 2024-EAB-0552 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's August 21, 2024, filing which, for reasons explained below, is construed as a request for reconsideration of EAB Decision 2024-EAB-0552. It has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and

appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

As a preliminary matter, claimant's August 21, 2024, filing does not explicitly request reconsideration of EAB Decision 2024-EAB-0552. Instead, it requests that EAB "open an inquiry to determine how the Administrative Judges arrived at the conclusions to the questions we have raised in the 4th and 6th paragraphs of this letter." EAB Exhibit 1 at 4. The filing otherwise expresses disagreement with various findings of fact and conclusions of law contained in EAB's decision. Because the purpose of the filing was to assert that errors of material fact or law have been made, it is construed as a request for reconsideration of EAB's decision. As such, the request must comply with the requirements of OAR 471-041-0145(2) to be considered.

The request for reconsideration was filed on August 21, 2024, which was within 20 days of the date EAB Decision 2024-EAB-0552 was mailed. However, it does not contain a statement that a copy of the request was provided to the employer. Therefore, pursuant to OAR 471-041-0145(2)(a), the request for reconsideration is dismissed.

DECISION: The request for reconsideration filed August 21, 2024, is dismissed. EAB Decision 2024-EAB-0552 remains undisturbed.
