

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0562

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 17, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department’s rules and was ineligible for benefits for the week of April 14 through 20, 2024 (week 16-24) and until the reason for the denial ended (decision # L0003620477).¹ On May 7, 2024, decision # L0003620477 became final without claimant having filed a request for hearing. On June 17, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant’s request, and on July 2, 2024, issued Order No. 24-UI-257844, dismissing the request as late, subject to claimant’s right to renew the request by responding to an appellant questionnaire by July 16, 2024. On July 22, 2024, Order No. 24-UI-257844 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On July 26, 2024, claimant filed a late appellant questionnaire response and application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant’s appellant questionnaire response and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 24-UI-257844, mailed to claimant on July 2, 2024, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 24-UI-257844 at 2. Order No. 24-UI-257844 also stated on its Certificate of Mailing, “Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than July 22, 2024.”

¹ Decision # L0003620477 states that claimant’s ineligibility for benefits was effective April 16, 2024. However, as benefit weeks begin on Sunday, and April 16, 2024, was a Tuesday, this is presumed to be a scrivener’s error.

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 24-UI-257844 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-257844 was due by July 22, 2024. Because claimant did not file their application for review until July 26, 2024, the application for review was late. Claimant provided a written statement with the application for review in the form of an appellant questionnaire response. However, claimant’s questionnaire response addressed only why the request for hearing was filed late and did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed July 26, 2024, is dismissed. Order No. 24-UI-257844 remains undisturbed.
