EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0563

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 8, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 145511). The employer filed a timely request for hearing. On January 18, 2022, and February 9, 2022, ALJ C. Smith conducted a hearing, and on February 17, 2022 issued Order No. 22-UI-186734, reversing decision # 145511 by concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving benefits effective October 3, 2021. On March 9, 2022, Order No. 22-UI-186734 became final without claimant having filed an application for review of Order No. 22-UI-186734 with the Employment Appeals Board (EAB). On April 1, 2024, claimant filed a late application for review of Order No. 22-UI-186734 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement included with claimant's late application for review, marked as EAB Exhibit 1. Copies are provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 22-UI-186734, mailed to claimant on February 17, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-186734 at 4. Order No. 22-UI-186734 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 9, 2022, to be timely."

(2) Claimant filed their application for review of Order No. 22-UI-186734 on April 1, 2024.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-186734 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-186734 was due by March 9, 2022. Because claimant did not file their application for review until April 1, 2024, the application for review was late. Claimant provided a written statement with the application for review. See EAB Exhibit 1. However, claimant's written statement did not describe circumstances preventing them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review of Order No. 22-UI-186734 is dismissed.

DECISION: The application for review filed April 1, 2024, is dismissed. Order No. 22-UI-186734 remains undisturbed.
